Discussion: General Manager provided an overview of the current USDA Loan. Current rate just over 4% and requirement for 10% reserve. General Manager also provided an overview of each potential funding partner and proposals. Refinancing would save approximately \$600,000. Funds currently used to meet USDA required reserve could be used to pay down loan and reduce time to repay loan or could be used to fund projects.
