## 10. MANAGERS' REPORT

## A. Orciouli Update

- a. There was a video call July 11, 2024 with Dan Boatwright of Castle Developers, GM Lepley and SCI Consulting to gather information about the development for assessment calculations.
- b. Castle is hiring Luhdorff & Scalmanini engineering to review available water capacity and determine well capacity requirements.
- B. CV Salts Program
  - a. GM Lepley and Josie Tellers, from City of Davis, will be leading the formation of a Management Zone for our area which includes up to 20 other districts, farming organizations and coalitions.
  - b. Formation will cost approximately \$250,000 for the engineering study. The cost will be split amongst all participating members.
- C. Cross Connection Control Policy
  - a. GM Lepley has created a Cross Connection Control Policy for ECSD.
  - b. Policy will be submitted to ECSD board for approval in September.
- D. Facility Master Plan Update
  - a. Expect to have initial review of findings and recommendations with the ECSD Board in August.
