#### MANAGERS' REPORT

- A. Lamb Valley Slough Repair
  - a. Final bid from Yolo Flood Control was \$10,000, consistent with original quote.
  - b. Work will begin when the ground has dried.
- B. Yolo County GSD
  - a. ECSD was maintaining Tuli Mem and Esparto Park for Yolo County from July through most of December, 2024 without a signed contract.
  - b. Yolo County GSD and ECSD signed a 6 month contract, retroactive for the period of July 1, 2024 through December 31, 2024.
  - Invoices for Tuli Mem and Esparto Park maintenance from July 2024 through November 2024 are now being paid by the county.
  - d. Contract for January 1, 2025 through June 30, 2025 was signed in January 2025.
  - e. GSD Director, Ryan Pistochini, has communicated that budget cuts for GSD are expected. Director Pistochini and GM Lepley will be meeting in late January to review ECSD services for Tuli Mem and Esparto Park.
- C. Security System
  - a. Two additional cameras will be installed at the shop. One camera will be inside the South Shop and one camera will be focused on the gas tanks and area surrounding.
  - b. Cameras at Tuli Mem will be repositioned for better coverage including the chemical and equipment storage area.
  - c. Upgrades to security cameras are estimated to be \$3,000 and should be completed by end of February.
