I have read and understand the following statements regarding service:

1. **There will be a \$25.00 new account service fee charged and payable with the next billing cycle.**
2. *The property owner is responsible for all plumbing, equipment and appliances from the point of connection to the District's system, which is typically located at the water meter connection.*
3. *The property owner is responsible for any damage to District equipment and facilities resulting from acts of the owner, tenants, agents, employees, contractors, licensees or permittees.*
4. *The property owner is responsible for maintaining unrestricted and unobstructed access at all times to District water meters and other District equipment and facilities located on their property.*
5. *The property owner agrees to pay to the District all charges and rates for the service provided pursuant to this application, including any outstanding amount and fees that may have been incurred by a tenant and any costs related to the collection of amounts due. Under the California Water Code (Sections 22284 and 25806), the property owner is responsible for all unpaid amounts owed to the District resulting from service provided to the premises. The District also has the right to place a Certificate of Lien on the parcel or pursue other collection opportunities*
6. *The property owner agrees that by applying for or receiving water service from the District, said owner irrevocably licenses the District and its authorized employees and representatives to enter upon the property owner's land at all reasonable times for the purpose of reading, inspecting, testing, checking, repairing, maintaining, or replacing the District's meters, District-owned water services, and water system components.*
