Resolution No. 20-01

ADOPTING DISCOUNTED FIXED WATER SERVICE CHARGES FOR RESIDENTS OF THE ESPARTO MOBILE HOME PARK FOR FEBRUARY 1, 2020 THROUGH JUNE 30, 2020 AND FOR FISCAL YEARS 2020/21, 2021/22, 2022/23, 2023/24 AND 2024/25

WHEREAS, the water service charges required to be charged to each user of District water service for District capital and operating and maintenance purposes in order to raise sufficient revenue for the District to provide water service were approved on November 13, 2019 at the District's regularly scheduled meeting under the Proposition 218 process (the "Proposition 218 Water Charges"); and

WHEREAS, the District is allowed by Article XIIID of the California Constitution, section 6, subdivision (b)(3) to impose discounted water service charges for which a record for the justification must be clearly established for the discount and that District cannot charge other District customers any water service charges which exceed the Proposition 218 Water Charges; and

WHEREAS, the District can justify imposing discounted water service charges for the Esparto Mobile Home Park (Park) by the fact that the District does not provide service up to the immediate vicinity of each Park's resident's home which it does do for the typical District residential customer; and

WHEREAS, the District will not charge any other District customer a water service charge which exceeds the Proposition 218 Water Charges; and

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF DIRECTORS OF THE ESPARTO COMMUNITY SERVICES DISTRICT HEREBY FINDS, DETERMINES AND RESOLVES:

- 1. The imposition by District of discounted water service charges for the residents of the Esparto Mobile Home Park is justified.
- 2. The District confirms that other District customers will not be charged any different water service charges as a result of the discounted charges, and the charges imposed on other customers shall not exceed the Proposition 218 Water Charges.
- 3. The District adopts a 10% discount of the Proposition 218 Water Charges for the residents of the Esparto Mobile Home Park.
- 4. The District adopts the attached Esparto Mobile Home Park Residential Monthly Fixed Water Service Charges for February 1, 2020 through June 30, 2020 and Fiscal Years 2020/21 through 2024/25.
- 5. The above recitals are true and correct statements of fact and are incorporated into this Resolution by this reference.
