

RESOLUTION NO. 25-03

RESOLUTION OF THE ESPARTO COMMUNITY SERVICES DISTRICT CALLING AND GIVING NOTICE FOR THE HOLDING OF A DISTRICT ELECTION TO BE HELD ON TUESDAY, NOVEMBER 4, 2025 FOR THE ELECTION OF BOARD OF DIRECTORS; REQUESTING THE BOARD OF SUPERVISORS OF YOLO COUNTY TO PERMIT THE COUNTY ELECTIONS OFFICE TO RENDER ELECTION SERVICES; AND REQUESTING THE CONSOLIDATION OF SAID ELECTION WITH THE YOLO COUNTY UNIFORM DISTRICT ELECTION LAW (UDEL) ELECTION HELD ON THE SAME DATE

WHEREAS, it is necessary for a District Election to be held within the Esparto Community Services District on November 4, 2025, for the purpose of electing two (2) full term members to the Board of Directors; therefore

BE IT RESOLVED that the Esparto Community Services District Board of Directors declares as follows:

1. Pursuant to Elections Code section 10400 et seq., the Board of Supervisors of Yolo County is hereby requested to consent and agree to the consolidation of the District's election with the County UDEL election to be held on Tuesday, November 5, 2025.
2. Pursuant to Election Code Section 13307 (a)(1), the candidate is to pay for the publication of the Candidate's Statement; and the limitation on the number of words that a candidate may use in his/her candidate statement is 200 words.
3. Pursuant to Elections Code section 10002, the Esparto Community Services District recognizes that consolidation of the Election with the County UDEL election, conducted by the County, provides the District an opportunity to share costs of conducting the election with other jurisdictions and, therefore, shall reimburse the County, upon completion of the work performed, for the District's share of costs incurred and upon presentation of an invoice to the District.
4. In the event of a tie vote, with any two or more persons receiving equal and the highest number of votes for a Board of Director position, as certified by the Yolo County Elections Office, the Esparto Community Services District, in accordance with Elections Code section 15651, subdivision (a), shall set a date, time, and place and summon the candidates who have received the tie votes to appear and will determine the tie by lot.
